

Video Request Policy

PERSONAL USE:

If the video is for personal use there is a \$25.00 fee for each request. What you will receive is a copy of the requested story, not the entire newscast. The segment you request may or may not be introduced by KSBY-TV news anchors. Also, only the footage that is seen on the air will be released. KSBY-TV does not release “outtakes”, i.e. extra footage shot at the time of the event, interview, etc. It is also important that you specify the newscast (*Daybreak, Action News at 5:00, 6:00 and 11:00*) in which your desired video appeared. Many times the subject will be covered in different forms depending on the newscast. If you would like more than one segment there is an additional \$25.00 for each.

COMMERCIAL USE:

Re-broadcasting or re-using the video obtained from KSBY-TV is expressly forbidden. If the video you are requesting will result from your financial gain, you must speak with the news director directly. All requests are considered on a case-by-case basis. A fee will be negotiated depending on each circumstance should the request be granted.

LEGAL USE:

It is our policy to comply with legitimate court-ordered subpoenas. However, we reserve the right to refuse a subpoena in extenuating circumstances. If you are requesting videotape or transcripts of material aired on KSBY-TV, and a court order subpoena is produced, the following fees will be charged:

-\$25.00 archival search fee for *each* story requested

-\$25.00 dubbing fee for *each* unique story copied in response to the subpoena.

We can not guarantee that we will have the segment you are requesting. In some circumstances copies of certain stories are not available.

Please send a check or money order to KSBY-TV, 1772 Calle Joaquin, San Luis Obispo, California, 93405. Specify on the request form whether you want to pick-up the material or have it sent to you. Allow 4-6 weeks for processing. Write “video request” on the outside of the envelope.
